Serious eye damage/irritation Ocular corrosive effect was assessed using the Isolated Chicken Eye method according to the OECD guideline 438; the outcome of this study shows that, at the 25% dilution level in water this material does not cause serious eye damage and therefore does not require the H318 classification and associated pictogram.
