## SECTION 4: First aid measures

### 4.1. Description of first aid measures

Take care of your own safety. If any health problems are manifested or if in doubt, inform a doctor and show him information from this safety data sheet. If unconscious, put the person in the stabilized (recovery) position on his side with his head slightly bent backwards and make sure that airways are free; never induce vomiting. ### If on skin

Remove contaminated clothes. Take off any rings, watches, bracelets before or during washing if worn in the contaminated areas of the skin. Rinse contaminated areas with a flow of water, lukewarm at best, for 10-30 minutes; do not use any brush, soap or neutralizers. Depending on the situation, call the medical rescue service and always ensure medical treatment.

### If in eyes

Rinse eyes immediately with a flow of running water, open the eyelids (also using force if needed); remove contact lenses immediately if worn by the affected person.
